SMALL COMMERCIAL SERVICE

APPLICABILITY:

To all commercial and industrial electric services 37 kilowatts and less and not specifically covered by any other rate schedule. Service will be provided at one point of delivery through one kilowatt- hour meter where capacity is available.

TERRITORY:

System wide.

RATE:

DEMAND CHARGE:

\$1.50 per month per kilowatt of billing demand

The billing demand is the greater of the measured kilowatt demand in the billing period, 50% of the maximum measured kilowatt demand in the previous eleven (11) billing periods, the Service Agreement contract demand, or 5 kW.

ENERGY CHARGE:

First 200 kWh per billing kW per month @ \$0.067527 per kWh;

Next 200 kWh per billing kW per month @ \$0.051927 per kWh;

All additional kWh per billing kW per month @ \$0.040227 per kWh

SERVICE AVAILABILITY CHARGE:

\$25.00 – no kWh allowed per month.

RENEWABLE ENERGY DISTRIBUTED GENERATION RIDER:


The renewable energy distributed generation rider applies to commercial and industrial electric services 37 kilowatts and less and not specifically covered by any other rate schedule that install a behind the meter renewable energy distributed generation facility.

SERVICE AVAILABILITY CHARGE:

\$25.00 per month

SMALL COMMERCIAL SERVICE

DEMAND CHARGE:

\$5.07 per month per kilowatt of billing demand

The billing demand is the greater of the measured kilowatt demand in the billing period, 50% of the maximum measured kilowatt demand in the previous eleven (11) billing periods, the Service Agreement contract demand, or 5 kW.

ENERGY CHARGE:

First 200 kWh per billing kW per month	@ \$0.0400 per kWh;
Next 200 kWh per billing kW per month	@ \$0.0375 per kWh;
All additional kWh per billing kW per month	@ \$0.0350 per kWh

STANDBY/BACK-UP SERVICE RIDER: X

The Standby/Back-Up Service Rider shall apply to: X

- A. All Small Commercial users that can self-generate fifty (50) kW or greater, or in other ways provide, a portion of their own requirements, but are capable of receiving a portion of their requirements from the Cooperative. X


Small Commercial users subject to the Standby/Back-Up Service Rider shall pay the Cooperative's applicable tariff charges and all additional charges billed by Western Farmers Electric Cooperative (WFEC) to the Cooperative pursuant to WFEC's Standby/Back-Up Service Rider filed at the New Mexico Public Regulation Commission. A copy of the WFEC tariff can be obtained from CVEC upon request. X

SMALL COMMERCIAL SERVICE

Consumers receiving service under this rate shall be required to execute the Cooperative's Service Agreement for any new service extension pursuant to the Cooperative's Extension Policy, Rule and Regulation No. 15


TAX ADJUSTMENT:

Billings under this schedule may be increased by an amount equal to the sum of the taxes payable under the Gross Receipts and Compensating Tax Act and all other taxes, fees, or charges (exclusive of ad valorem, State and Federal income taxes) payable by the utility and levied or assessed by any Governmental authority on the public utility service rendered, or on the right or privilege of rendering the service, or on any object or event incidental to the rendition of service.

FUEL AND PURCHASED POWER COST ADJUSTMENT:

The charge per kWh of the above rate shall be increased or decreased by the amount that the Cooperative's purchased power cost per kWh exceeds or is less than \$0.054657 per kWh as specified by NMPRC Rule 550 and any New Mexico Public Regulation Commission approved variance from the Rule.
