installed on any suitable mounting device of the consumer. Overhead, secondary line spans will not exceed 100 feet. The cost of each span required by the initial 100 foot span shall be paid by the Consumer prior to construction. Lights will not be installed on any mounting device, which in the opinion of the Cooperative is unsafe or not suitable for this purpose.

CONDITION OF SERVICE:

Consumers receiving service under this rate shall be required to execute the Cooperative Service Agreement for any new service. All facilities installed on the consumer's premises remain the property of the Cooperative. Consumer is responsible for notifying the Cooperative in the event the yard light fails and requires maintenance. Replacement of lamps, material and labor for repairs and maintenance will be furnished by the Cooperative during regular working hours.

TAX ADJUSTMENT:

Billings under this rate may be increased by an amount equal to the sum of the taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, State and Federal income taxes) payable by the utility and levied or assessed by any Governmental authority on the public utility service rendered, or on the right or privilege of rendering the service, or on any object or event incidental to the rendition of the service.

FUEL AND PURCHASED POWER COST ADJUSTMENT:

The charge per lamp under the above rate shall be increased or decreased (based on kWh per month specified for each lamp) by the amount that the Cooperative's purchased power cost per kWh exceeds or is less than \$0.054657 per kWh, as specified by NMPRC Rule 550 and any New Mexico Public Regulation Commission approved variance from the Rule.


