## INSTALLATION AT THE POINT OF CONNECTION Application – All Customers

- The consumer will cause to be installed by a New Mexico licensed electrician the meter loop, where applicable, using a meter base supplied by the Cooperative. Upon the Cooperative's receipt of approval from the New Mexico Regulations and Licensing Department, Construction Industries Division (NMRLD/CID) electrical inspector, or a signed Statement of Fact, provided by the Cooperative, from both the New Mexico licensed electrician and an electrical inspector certified by the International Code Council or such other certification entity that is recognized by the Cooperative (Certified Inspector) from a list maintained by the NMRLD/CID and located on its website, the Cooperative shall install the metering device and provide service. The meter loop shall remain the property of the consumer, shall be subject to any applicable New Mexico statutes, codes or regulations and shall be the point of transfer of ownership of delivered capacity and energy. Should at any time the Cooperative determine the consumer's meter loop is unsafe or hazardous to the consumer or the general public, the Cooperative may discontinue service until such time corrective measures have been placed into effect by a New Mexico licensed electrician, subject to any New Mexico or Cooperative permitting requirements, as previously stated and the condition resolved. The Cooperative will provide all other protective equipment as required for the protection of the Cooperative. The consumer will be responsible for the installing and maintaining the necessary protective devices for the consumer's equipment on the consumer's side of the meter.
- B. All meters will be installed on meter pole furnished by the Cooperative, unless authorization is obtained from Cooperative in advance.
- C. All service connections, repairs and replacements from or to the Cooperative's system are to be made by Cooperative authorized personnel only and under the supervision of the Cooperative.
- D. The consumer must agree, in accepting service, that no one except the employees of the Cooperative shall be allowed to make internal or external adjustments of any meter or any other piece of apparatus which is the property of the Cooperative.

	that all future additions on the load side of the primary meter shall be constructed and inspected following the same aforementioned process ensuring all federal, state and local requirements have been met.	X
