### TAX ADJUSTMENT:

Billings under this schedule may be increased by an amount equal to the sum of the taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, State and Federal income taxes) payable by the utility and levied or assessed by any Governmental authority on the public utility service rendered, or on the right or privilege of rendering the service, or on any object or event incidental to the rendition of service.

Cotton Gin Service users subject to the Standby/Back-Up Service Rider shall pay the	X
Cooperative's applicable tariff charges and all additional charges billed by Western Farmers	X
Electric Cooperative (WFEC) to the Cooperative pursuant to WFEC's Standby/Back-Up	X
Service Rider filed at the New Mexico Public Regulation Commission. A copy of the WFEC	X

#### CONTRACT:

Consumers receiving service under this rate shall be required to execute the Cooperative's Service Agreement for any new service extension pursuant to the Cooperative's Extension Policy, Rule and Regulation No. 15.

# FUEL AND PURCHASED POWER COST ADJUSTMENT:

The charge per kWh of the above rate shall be increased or decreased by the amount that the Cooperative's purchased power cost per kWh exceeds or is less than \$0.054657 per kWh, as specified by NMPRC Rule 550 and any New Mexico Public Regulation Commission approved variance from the Rule.
