### **Energy Efficiency Program & Rebates**

Central Valley Electric Cooperative promotes the installation of ENERGY-STAR-rated windows to help make your home more efficient.

#### **PROGRAM CONTENT**

CVE provides residential members with a rebate on the installation of ENERGY-STAR-rated windows.

#### **PROGRAM PROVISIONS**

##### **Program Qualifications & Restrictions:**

1. The installation of ENERGY-STAR-rated windows must be installed in a permanent residence that CVE serves.
2. To qualify for a window rebate, the home must be cooled by refrigerated air conditioning or heated with electric resistance heat or have a heat pump.
3. New construction and additions to existing homes do not qualify for window rebates.

##### **ENERGY-STAR-rated Window Rebate**

1. Rebate of forty percent (40%) of window costs (taxes and labor not included).

#### **PROGRAM RULES & GUIDELINES**

- Must include a copy of a dated receipt for window costs or a paid-in-full contractor invoice and ENERGY-STAR-rated verification.
- You must provide pre- and post-pictures of the windows.
- All ENERGY-STAR-rated windows must be brand new.
- Windows must be installed in accordance with all applicable local, state, and national codes and ordinances.
- Windows must be fully installed before a rebate can be issued.
- Members must apply for rebates within 90 days of installing the windows. Rebates will be issued within 30 days of the approved application.

- Rebates will be given in the form of a check or utility bill credit.
- CVE does not guarantee a specific level of energy or cost savings will result from installing or using products funded under this program.
- CVE is not liable for any damages caused by the operation or malfunction of the installed equipment.
- CVE reserves the right to inspect and verify that windows were installed.
- Rebates will be capped at \$75,000.00 annually for any one member. This amount applies to the combined total of all other CVE rebate programs.
- To receive the rebate, CVE members must be current (within 60 days) in the payment of their account(s).

#### **PROGRAM FUNDING**

Funding for this program comes from CVE's Renewable Energy and Energy Conservation Fund. Should this fund become deficient, the window rebate program will become inactive until such time funds are available.
